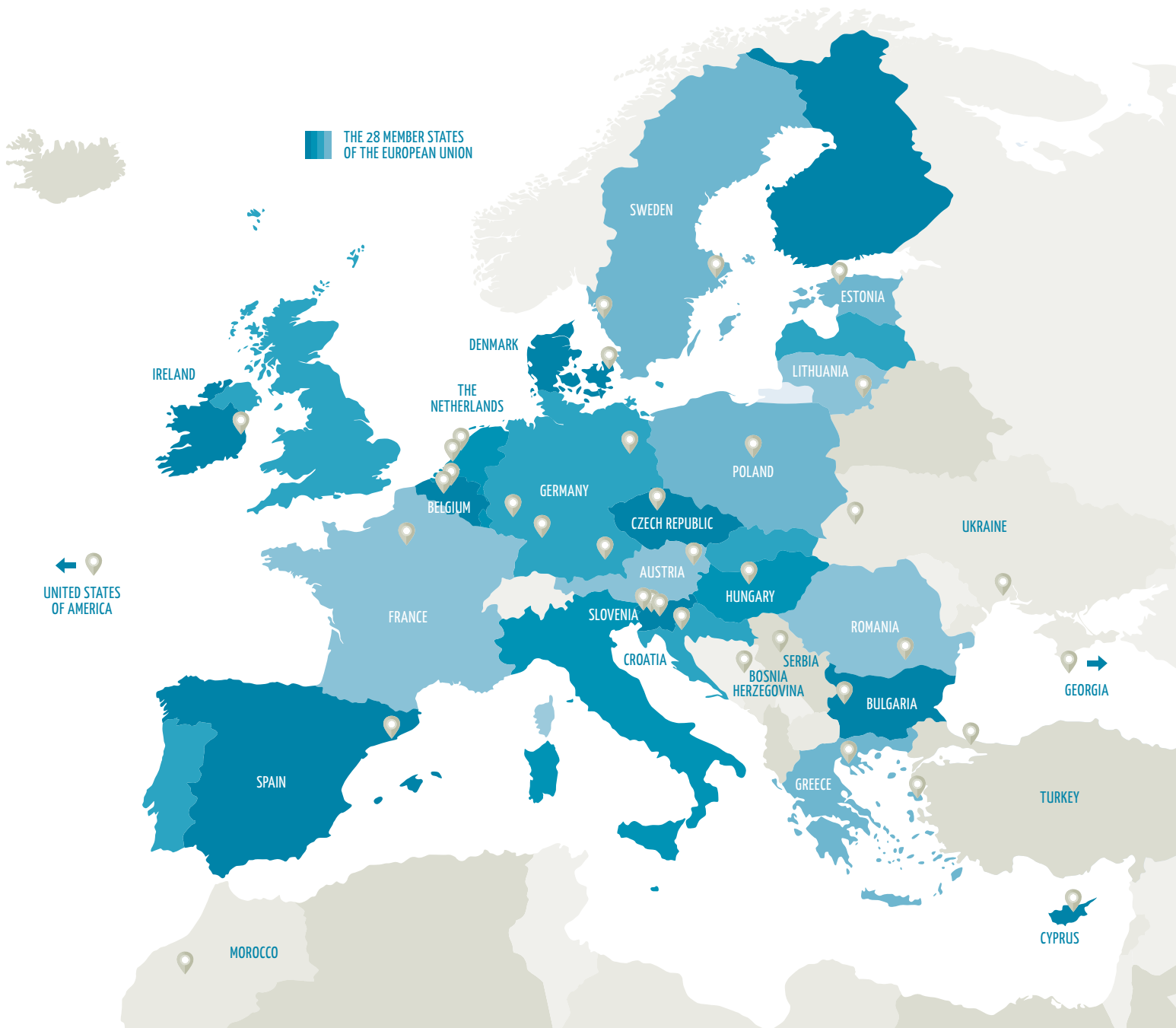

# MAKING EUROPE SAFER FOR CITIZENS

Five ELF member organisations, namely the Friedrich Naumann Foundation – Prague Office, the Liberaal Kenniscentrum, the Academy of Liberalism, Svenska Bildningsförbundet (SBF) and the Institute for Politics and Society (IPPS), closely collaborated during 2016 in the field of security. The ELF project “Making Europe Safer for Citizens” launched a seminar and two workshops that took place in Brussels (at the European Parliament) and Tallinn.

While following up on a previous 2015 ELF project, the events aimed at fostering dialogue and raising awareness of citizens on the topic of a common European defence and military policy. Input was provided by prominent speakers, such as **Alexander Graf Lambsdorff MEP**, **Hilde Vautmans MEP** and **Urmas Paet MEP**, as well as security experts from all over Europe and the US (**Dr Stefanie Babst**, Head, Strategic Analysis Capability to the NATO Secretary General and Chairwoman of the NATO Military Committee; **Taavi Roivas**, then Prime Minister

of Estonia; **Dr John R. Deni**, Research Professor, Strategic Studies Institute, U.S. Army War College).

The discussion aimed to engage citizens in topical issues related to defence and security policies, and to share information with the participants. These policies are

highly politically sensitive both on a European and on a national level, because they are closely related to national sovereignty, as Alexander Graf Lambsdorff MEP pointed out. For a long time, the absence of any military threat has inhibited any progress in genuine cooperation within the European Union. Yet, a new geopolitical context after

# EUROPE'S ENERGY FUTURE

## HOW TO REDUCE TRANSPORT EMISSIONS AND INCREASE ENERGY SECURITY

Following up on a 2015 project, ELF gathered five member organisations to discuss energy and the environment, with a specific focus on transport. A series of three preliminary workshops and a final roundtable hosted by **Frederick Federley MEP** and **Gesine Meißner MEP** at the European Parliament resulted in a joint publication entitled *Europe's Energy Future: How to reduce Transport Emissions and Increase Energy Security*.

The discussion highlighted the challenges and opportunities of the European transport sector, and the presence of prominent experts, such as **Jakob Lagercrantz**, founder of the 2030-Secretariat, **Emily Rochon** from Greenpeace and **Philippe Guichard** from Total, benefitted the breadth of the discussion.

Though energy and transport are highly technical sectors and require specific knowledge, the speakers pointed out the need to raise the awareness of policy-makers,

so they have a broader picture of the technical solutions likely to have an impact on both climate and energy security. During the first and the second seminar, Jakob Lagercrantz and **Lovisa Källmark** from Fores advocated for concrete proposals to meet climate goals and higher

levels of energy security, while the third seminar focused on country case reports and discussed their relevance with a view to regional differences.

The fact that Europe is a net importer of energy, largely dependent on fossil fuels from the successor states of the former Soviet Union, raises some questions: what

is the current state of affairs; what alternatives are there for increasing fuel efficiency; what alternative fuels and transport systems exist, or will be developed in the future? With respect to energy security, there are two major risks involved: political risks and economic risks, such as the unstable relations with Russia and the Southern Mediterranean region, and the volatile prices of fossil fuels. However, there are ways out of this dependency: increasing energy efficiency and substituting conventional fuels with more sustainable alternatives.

Furthermore, citizens’ attitudes and behaviour play an important role: while raising awareness about the risks and the alternatives to fossil fuels already available, public participation based on (local) knowledge can lead to more sustainable energy solutions (biogenic renewables, solar energy and wind energy).

# EUROPEAN REFUGEE CRISIS

## LIBERAL ANSWERS TO THE CHALLENGES ON SEA LIBERAL ANSWERS TO CHALLENGES ON LAND INTEGRATION THROUGH EDUCATION

Lesbos, Belgrade, Sofia and Stuttgart were all visited by participants in the ELF project dealing with the European refugee crisis implemented by Friedrich Naumann Foundation (Regional Offices of Bulgaria, Greece and Europe), together with Republikon, Novum, KEFIM, Centre for Liberal Studies and LibMov.

The challenges on sea and land brought about by this colossal humanitarian emergency is raising a need for Liberal answers. A group of young Liberals thus travelled through the Balkans and to the Greek island of Lesbos to visit the refugee camps and talk to the volunteers on the front line of engaging with asylum seekers.

The first seminar was held in Lesbos, Greece, where the group visited the camps of Kara Tepe and the Lesbos Solidarity Camp. There, they met with **Stavros Mirogiannis**, the manager of the Kara Tepe camp, and **Jean-Pierre**

**Schembri**, spokesperson for the European Asylum Support Office (EASO). They both called upon a global response as the only way to address the refugee crisis. **Shadi Martini**, a former Syrian refugee who is now a humanitarian activist

and journalist, agreed. After welcoming the participants in Sofia, he explained that Europe should work towards the gradual integration of refugees in our societies by providing them access to the labour market and encouraging mutual dialogue with European citizens, so as to debunk the myths regarding refugees. He also affirmed that integration should

not come at the price of security, and that the regulation of migration is a top priority.

After moving to Belgrade, where the group visited the Krnjaca facility and spent time listening the refugees' stories and playing with the children, the group met with the volunteers of the refugee camps in Belgrade. **Tajana Zdravec**, who works for Miksaliste Refugee Aid Centre, and **Dajena Ristic**, coordinator of Krnjaca Refugee Facility, confirmed that the camps are at their largest capacity, and that huge efforts are made on a daily basis to welcome every newcomer, and distribute basic needs such as food, water and clothes. After these testimonies, the participants worked in small groups to translate the outcomes of the previous roundtables into a preliminary study.

The project's final conclusions were drawn by **Angelika Mlinar MEP**, who stressed the need for a reform of the Dublin Convention and the willingness to work towards a common asylum and migration policy. While criticisms of the role of Frontex and the "web of institutions" that is has been tasked with managing migration flows were voiced, **István Dobo**, Policy Officer at the European Commission, acknowledged the action of Frontex, and called upon European institutions to increase and strengthen their support for this structure.

The final outcome of the project was a video, available on [ELF's Youtube channel](#), gathering what the participants saw during their workshops around the Balkans and Greece.

# TALK FOR EUROPE

## RALF DAHRENDORF ROUNDTABLE

The future of Europe is in the spotlight with **Guy Verhofstadt MEP**, president of the ALDE Group and **Andrej Babiš**, then Finance Minister of Czech Republic, as special guests of the ELF Ralf Dahrendorf Roundtable held in Prague, Czech Republic, on 19 September 2016 and implemented by the Institute for Politics and Society. The debate was moderated by Czech MEP **Pavel Telička**, Vice President of the European Parliament.

Since 2009, Europe has been facing a number of challenges. Economically, the past few years have been particularly difficult for the euro zone, and the sovereign debt crisis is only now showing some signs of alleviating. In terms of security, the situation on the EU's eastern border is once again the subject of much attention: Russian aggression in the Ukraine persists, challenges regarding the stabilisation of the Ukraine remain and EU's energy dependency on Russia remains a heated topic. More recently, Brexit has stolen much attention and promises to be on the agenda for some time, as does the refugee crisis, to which a

common European solution has yet to be found. Europe is going through a time of much soul-searching as divisions between the East and the West reappear.

Disappointed by the outcomes of the Bratislava summit, Andrej Babiš called for more action and competent

leaders to handle this historical “turning point”, as Pavel Telička MEP named it. He added that Europe should deliver and recover in times where voters are fed up with a “Europe à la carte”. Reforms are possible and necessary for the survival of the Union, argued Guy Verhofstadt MEP: “we need a common euro-zone governance, but

we need fewer commissioners, fewer unimportant tasks; we need a small, effective EU government that deals with important issues such as defence and finance", and the sooner, the better. Unlike what one could think, he continued, events such as Brexit do not pose economic issues, but rather, geopolitical ones, with Europe left divided in a new age of empires.

This is one of the multiple challenges we are facing, but other questions remain unanswered: do any countries bear a responsibility to accommodate refugees? What distinguishes a refugee from an economic migrant? Do countries militarily involved in the Middle East such as the United Kingdom and France bear a greater responsibility than those uninvolved in the Iraqi/Syrian civil war? For how long, if at all, can Schengen survive under the current circumstances? Do migrants pose a threat to security?

# DIGITAL SECURITY DUET

## MAKING EUROPEAN CYBER DEFENCES MORE RESILIENT THROUGH PUBLIC PRIVATE PARTNERSHIPS

The high-level Ralf Dahrendorf Roundtable (RDR) discussion organised by ELF on cyber security and public-private partnerships at the Munich Security Conference (MSC) in Munich, one of the most prestigious conferences on security policy, took the next step in developing ELF's network of defence and security experts.

The discussion was moderated by **Marietje Schaake MEP**. As member of the Global Commission on Internet Governance and as founder of the European Parliament Intergroup on the Digital Agenda for Europe, Marietje Schaake MEP is an authority in the field of governance of the digital world.

The speakers exchanged best practices on cybersecurity and the need for a fully-fledged international cooperation including the private sector, too. The expertise provided by private experts may afford smaller countries, such as Estonia, to develop cyber capabilities in every branch of

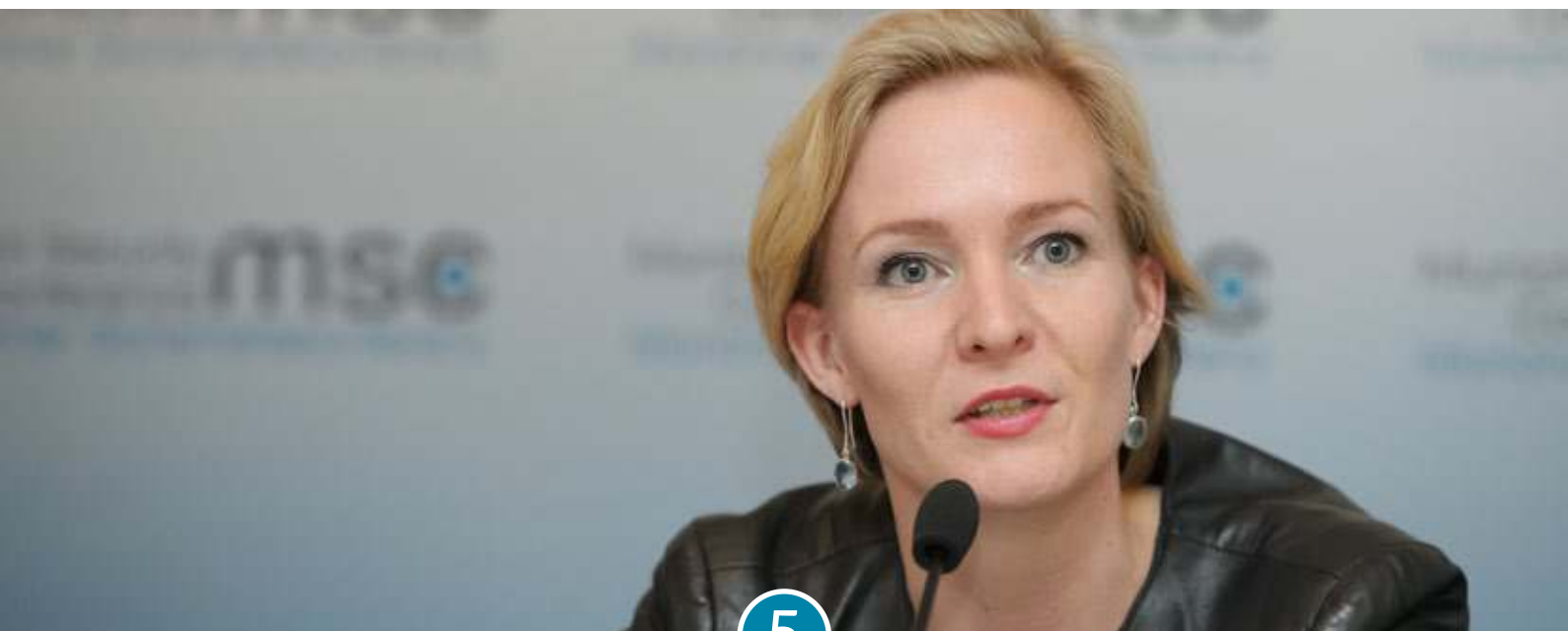
the government, as **Marina Kaljurand**, then Estonian Minister of Foreign Affairs argued. While not scared of a "Big Brother government", she expressed major concerns about the "Little Sisters, the small and big companies like Google and Microsoft", that control data on individuals and may manipulate them.

The second speaker, **Jan Neutze**, Director of Cybersecurity Policy at Microsoft and responsible for Europe, Middle East, and Africa, pointed out that public-private partnerships were both effective and fragile because they were based on mutual trust.

At Microsoft, he said, “we often saw the public and the private sector agreeing on which problems need to be solved, but that they did not work together to solve them”. When talking about accountability, Jan Neutze pointed out that the private sector is the one controlling most of the infrastructure but the governments are the ones who set the rules. He gave the USA as a good example of cooperation between the private and the public sector, and called for sharing more information over the Atlantic.

The third speaker was **Gerhard Eschelbeck**, Vice President Privacy and Security Engineering at Google. Even though threats are developing fast, he emphasised

that governments try to control the developments too much, and therefore essential information or innovations might not be shared in time. But there are also good practices to mention, like the German government organisation for information security, BSI.

One of the members of the audience was **Birgitta Jónsdóttir**, member of the Icelandic parliament for the Pirate Party. She emphasised that online civil rights should always be taken into consideration when implementing cyber security and data sharing policies, and the speakers lastly agreed on the need to focus on data integrity, and on the commitment to protect users’ rights.

Opened in December 2004, the Centre Jean Gol is, at one and the same time, the guardian of the archives of the Reformist Movement and a number of its directors; an interdisciplinary library boasting over 4,000 volumes (seminal liberal writings, but also less well-known works); a design office; a think tank and research unit; a publisher of numerous collections; a proactive political force; a centre for training the Reformist Movement's representatives; and an organiser of events, seminar, conferences and symposiums.

The Centre Jean Gol's objective is to generate discussions on important social issues, thereby enabling the Reformist Movement to promote new ideas as part of a message that is accessible to all. In other words, the Centre Jean Gol allows the Reformist Movement to express itself as a vital creative force.

Apart from reference works on liberalism, the Centre Jean Gol publishes *Cahiers*, the fruit of an interdisciplinary discussion process involving political authorities and experts from academic and socio-economic spheres or from civil society. It updates a database of electoral results since the early 1990s, from which it produces in-depth analyses. It also places itself at the disposal of the Reform Movement's elected representatives to carry out surveys and work on specific election projects.

Finally, the Centre Jean Gol has a website, designed to serve as a communication tool for the activities and publications of the centre. It offers online access to our library catalogue and to the inventory of our archives; the option to download certain parts of our publications free of charge; a "Liberal Portal" providing several hundred links to other websites (Liberal or otherwise) of interest; plus a section entitled *La Pensée Libérale*, which gives access to analyses of major liberal works, bibliographical references, etc.

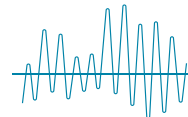

# PROF.MR. B.M. TELDERSSTICHTING

The Prof.mr. B.M. TeldersStichting is a Dutch liberal think tank affiliated to the VVD political party. The foundation is named after Benjamin Telders, who was a legal scholar and philosopher and chair of the Liberal State Party (a predecessor of the VVD party). During World War II he was arrested by German (Nazi) occupiers. He died in the Bergen-Belsen concentration camp shortly before the Netherlands were liberated.

The Prof.mr. B.M. TeldersStichting was founded in 1954 as a completely independent liberal think tank by a board under the chairmanship of Johan Witteveen, a professor in economics who was to become Vice-Prime Minister of the Netherlands in the 1960s and Director of the International Monetary Fund in the 1970s. In 1972, the Prof.mr. B.M. TeldersStichting established a link with the VVD, although as an organisation and in its policy formulation, the think tank remained independent. The current Chair of the Board is Robert Reibestein, who was previously a partner of McKinsey & Co. consulting services company. The current Director of the foundation is Patrick van Schie, a historian who wrote his dissertation on the history of Dutch liberalism from 1901 to 1940.

The Prof.mr. B.M. TeldersStichting publishes policy papers and books on all kinds of political and societal topics, from the market economy to environmental issues, from fighting crime to defence policy. In addition, together with a commercial book publisher, the foundation publishes books for a wide audience on the history of liberalism and its leaders, the political philosophy of liberalism and the leading thinkers in liberal (political and economic) theory. Each year, several conferences and seminars on various topics are organised. Also, an annual Telders Lecture is held. Talented students from Dutch (and Belgian) universities are selected to take part in the Prof.mr. B.M. TeldersStichting Liberal Summer School. The quarterly journal of the foundation is *Liberaal Reveil*, which is edited by Charlotte Maas. The TeldersCommunity, an online platform for

discussion as well as a digital library for all our publications was launched in 2014. Most of our publications and debates are in Dutch, although some are available in English.

The Prof.mr. B.M. TeldersStichting does not adhere to one particular variant of liberalism, though liberalism's classical thinkers always appear to be an important source of inspiration. For us, the freedom of the individual is the most fundamental point. We therefore consider it essential that a free and democratic society, in which there is no accumulation of power and public power is always democratically controlled and legitimised (via checks and balances), continues. It is not the US-type of liberalism, as it has developed in recent decades, that we embrace, but a liberalism that is vigorously opposed to socialism, religion-based politics and other kinds of communitarianism.
