

Events and Projects

2020 was an unprecedented year in many respects, but it was one that pushed us to be flexible and to experiment with a host of new formats for our projects and events.

What started as a dynamic and optimistic year for ELF, with our biggest number of projects yet, saw a sobering up in light of the COVID-19 pandemic. Nevertheless, ELF quickly bounced by back trialling our first webinar series, "Liberties in Lockdown", examining the health of our democracies, and civil liberties in a time of unprecedented restrictions during a pandemic. This later grew into a regular webinar series "On the Agenda", discussing the key topics making headlines in Brussels and beyond.

Our members showed remarkable resilience organising hybrid events, and reaching audiences with new formats including podcasts, audiobooks, interactive publications, online learning modules, and, of course, hybrid conferences.

Whilst the post-pandemic recovery quickly became the focus of many of our events and research, 2020 saw ELF and its members continuing to engage in key policy debates such as: Updating European migration policy, EU Emissions Trading System and Climate clubs, enlargement and stability in the Western Balkans, introducing i-voting as a solution for citizens living abroad, and protecting human rights in the 21st century.

Taking place as a flight-free edition, our flagship Brussels event, the ELF Idea Accelerator, again showcased new liberal ideas from across the ground in Europe.

Last but not least, our most ambitious and visionary project for 2020 saw ELF organise a series of eight high-level expert forums on migration, security, rule of law, institutional frameworks, digitalisation, sustainability, trade, and social policy, which fed into the creation of our Liberal White Book, a blueprint for a fairer and freer Europe by 2030. Watch this space in 2021 for the official launch.













Events & Projects



Youth Academy

Supported by Academy of Liberalism

The main idea behind the Youth Academy was the creation of a leadership training programme for liberal youth. A series of 2 on-site sessions and online work, with mentoring in between, served as training for youth people willing to become the next influencers in the political field or great leaders with a liberal worldview.

US-China relations: Lessons for the EU

Supported by Centre Party International Foundation (CPIF)

The power struggle between the U.S. and China, in terms of grand strategy as well as military strategy, served this project in helping European stakeholders and decision-makers understand the rationale behind the U.S. response to emerging and existing Chinese defense & security policies. The project inspired and educated interested parties in the ways the U.S. perceives Chinese strategy and policy in the aforementioned areas and what Europe can learn from that. The project set the stage for a profound and well-structured case for liberalism as a vital tool in countering totalitarian inclinations.





Civic Platform for Young Liberal Activists

Supported by Centre Party International Foundation (CPIF)

The project aimed to trigger the interest of young people in political activism within the broad spectrum of civil society, including political parties, NGOs, and social movements. Young people from all around Southeast Europe gathered with young representatives of liberal political parties to learn techniques for raising awareness about local social, political, and cultural issues and how these skills could later by applied to youth activism.

Liberties in Lockdown Series


To better understand the consequences and the impact of Covid-19 on our freedoms, ELF launched its weekly online webinar series, Liberties in Lockdown, which allowed experts and liberal leaders to discuss and explore the multi-facetted degradation of these rights. The eleven debates also showed how Covid-19 indeed gave a window for more reflection about what future we want for Europe and its citizens, with an opportunity to reshape our priorities in terms of policies and investments.





Thought Bites

Thought Bites consisted of short videos submitted by MEPs in which they had the occasion to answer specific questions relating to recent events and current affairs in a snappy and down-to-earth format. The project aimed to strengthen engagement with ELF's network and beyond and generate thinking about topical EU questions.



On the Agenda

Following on from the success of the Liberties in Lockdown webinar series, ELF launched a new online event series in which to discuss current topics and events. While the world was trying to recover in the aftermath of this health crisis, it was the moment to shape what the EU and its member states were putting on their agendas in the short, medium and long-term. ELF believes that what gets put on the agenda is as important as what gets left out, and, with this new series of webinars, tackling head-on the most pressing issues in Europe.



Dare to Debate & Thinking Aloud

This year, we dared to debate about the digital revolution and whether certain scenarios are closer to reality or sci-fi, with the Institute for Politics and Society. Our Thinking Aloud events, three TED-style talks, featured Alberto Alemanno on How to make EU citizenship future-proof, Kadri Simson on How to cope with climate change, and Timothy Garton Ash on Prospects for freedom in Central Europe at the Freedom Games in Lodz. These talks were published in cooperation with Friedrich Naumann Foundation, Academy of Liberalism, and Fundacja Liberté!

Liberal White Book – A Liberal Europe 2030

To renew the European Union, we need to define the goal that we are striving for. To determine this, we organised a series of nine high-level expert forums, bringing together top academics, policymakers, and practitioners on the key topics for Europe. Collected together, with each chapter endorsed by an MEP, The Liberal White Book - Europe 2030 is our vision of a liberal Europe and how best to reach it.



All Things Liberal

Reaching and convincing liberal audiences is not always best achieved through dense and detailed publications. Therefore, the Secretariat created a series of 4 educational videos for European citizens to present some key topics at the European level alongside the liberal take on them: trade, consumer choice, innovation, and the rule of law.



Competence Centre meetings

The Competence Centre meetings brought together member organisations who were hoping to apply for ELF projects in 2021. This represented a great opportunity to pitch ideas, receive feedback from peers, and broker joint projects with others working on similar topics.





ELF Administrative Training

ELF Member Organisations gathered in Brussels to kick-off the year with a project management and administration training. Through interactive sessions and group work, we covered the A-to-Z of doing projects with ELF, especially how to create meaningful and engaging events.



Idea Accelerator: The Future is Digital

The 2nd edition of ELF's flagship event — the Idea Accelerator — took place online in a "flight-free" format. Joined by our member organisations, we presented ways in which liberals can make the world a better place. Including notable contributions from Kristin Schreiber and MEPs Martin Hojsik and Svenja Hahn, we took a creative look at how to support the recovery of European industry, how to approach sustainability questions, how countries can regulate more smartly, and why we should not fear the future, but own it.



Values First? Promoting EU Norms Through Trade

Supported by European Liberal Youth (LYMEC)

The project aimed to gather the thoughts of young liberals to explore international trade developments and how the core values of the EU are reflected in (free) trade agreements and investments with third countries. Starting from an exploratory seminar in Luxembourg, looked at different aspects of EU trade strategies, including human rights, climate change, and normative approaches to promoting values through trade. A compilation of essays written by young liberals was later presented to MEPs and interested stakeholders in Brussels.



Energising Europe: Raising Climate Ambition, Boosting Energy Solutions

Supported by European Liberal Youth (LYMEC) When it comes to addressing one of today's hottest topics such as climate change, ideas within liberalism such as the free market, freedom of movement, and globalisation are often pointed out as the issue. Therefore, the project aimed to show how liberalism can tackle climate change and not be the actual cause of it.

Capacity Building Seminar on Cyber Security, Blockchain and Big Data

Supported by European Liberal Youth (LYMEC) Given the devastating consequences of cyber-threats and attacks, issues related to cyber-security have never been more important for the EU's path to digitalisation. Therefore, this project focused on capacity building and knowledge for young liberals, equipping them with concrete tips and a handbook to be shared among the community.

Young Leaders Meeting

Supported by European Liberal Youth (LYMEC)

This project helped foster liberal leadership by bringing together presidents of youth organisations to exchange and discuss best practices, mutual benchmarks, common challenges, and opportunities, as well as peer support. This year's focus was digital policies: what are the core tenets of a liberal digital policy and how can young people help to shape it?

Al in the EU: Towards a Trustworthy Development of Artificial Intelligence

Supported by Forum for Reforms, Entrepreneurship and Sustainability (FORES)

This project assessed and compared five national AI strategies, in light of the EU's strategy and connected Coordinated Plan on Artificial Intelligence, to strengthen an ethical, trustworthy, and cutting-edge AI made in Europe. The results are being used to understand how national and European level strategies interact in terms of ensuring that AI applications remain ethical and transparent. It hopes to focus and enhance the policy-relevant AI-debate in the coming years.

The EU's Emissions Trading Scheme in Light of the Paris Agreement

Supported by Forum for Reforms, Entrepreneurship and Sustainability (FORES)

This project served as an analysis of selected Member State policies that were more ambitious than the ETS and which interacted with it. In addition, the project aimed to outline possible solutions to how this liberal market mechanism could be reformed and become more ambitious, while also ensuring liberal market-based policy effectiveness.



Does Europe Need More Private Funding and Organisation of Investment?

Supported by Forum for Reforms, Entrepreneurship and Sustainability (FORES) Transport infrastructure investment is costly. Private capital can be helpful, both for funding and incentives, but can have several drawbacks. This project aimed to find the best solutions based on research and examples from several countries and spread them via a book, several launches, and direct contact with policymakers.




See you in court - the Effectiveness of Litigation as a Climate Tool

Supported by Forum for Reforms, Entrepreneurship and Sustainability (FORES)

As rule of law is a foundation of liberalism, this project studied litigation as a tool to tackle climate change. This is a relatively new phenomenon that has emerged through court cases in recent years, notably in the Netherlands and the UK. Thus, this study provided an overview and assessment of how EU governments and companies were increasingly being held to their policy climate change commitments through legislative channels.







Trading to Make the EU Prosperous and Green

Supported by Forum for Reforms, Entrepreneurship and Sustainability (FORES)

This project brought out how climate policy can be furthered through trade by looking at possibilities like including "green" factors in EU free trade agreements to a greater extent, and how green technology can serve to use trade as an empowering tool.

eDemocracy - Driving Citizen Advocacy Through Digital means

Supported by Friedrich Naumann Foundation (FNF)

Some governments have been cautious about enabling state-led eDemocracy initiatives for citizen involvement in policymaking. Yet digital means present an opportunity for individual citizens to become more involved in democratic decision-making processes and hold governments to account. This project researched, collected, assessed, and presented the ever-growing number of innovative good practices in citizen-led, informal participation and methods for government scrutiny through digital means.



I-Voting: A European Solution for Citizens Living Abroad?

Supported by Friedrich Naumann Foundation (FNF)

Millions of Eastern Europeans live and work abroad. Because of geographical reasons and few polling stations in their countries of residence, their right to influence the democratic development of their home country through voting is denied. This project therefore examined if internet voting could be a solution, taking Romania and Moldova as case studies for the potential development of i-voting solutions across Europe.

Improving Communication on Human Rights

Supported by Friedrich Naumann Foundation (FNF)

This project aimed at tackling the safety and wellbeing challenges that human rights defenders face in their work while educating them and the broader public about the EU's action and policy in the field of human rights and democracy, as well as how this can be improved through liberal solutions.



European Women's Academy in Eastern Europe

Supported by Friedrich Naumann Foundation

The European Women's Academy in Eastern Europe was a state-of-the-art training and capacity-building programme for women in politics. The programme included training sessions on personal branding, communication, media relations, public relations, fundraising and data analysis.

The European Women's Academy this year focused on a celebratory almunae session bringing together participants and trainers from the EWA Family over the last few years for a high-level online summit. As a result of the reflection, EWA has rebranded into The Alliance of Her.

A Voice for the Youth

Supported by Friedrich Naumann Foundation

A Voice for the Youth was a two-stage policy development and lobbying initiative for young leaders across Europe. The first stage took place in an online workshop, where they met with relevant stakeholders to develop two coherent policy proposals; later they lobbied for these proposals to the Renew Europe Group and EU institutions from Brussels.









The Euro-MENA Freedom Project

Supported by Friedrich Naumann Foundation (FNF)


The "Euro-MENA Freedom Project" constituted the blueprint to achieve constructive cooperation between the liberal networks of Europe and the MENA region. The project aimed to represent a liberal call to counter extremism, create innovative solutions for socio-economic threats, and consolidate efforts through a common 2025 agenda.



ELF HUB at The Freedom Games 2020

Supported by Fundacja Liberté!

The ELF HUB at the 2020 Freedom Games was an exclusive part of the Games – an interdisciplinary forum of ideas – bringing together academics, politicians, thinkers, writers, and NGO leaders to explore ideas of Freedom in society, politics, and cultural domains. ELF's hub at the hybrid conference based in Łódź sought to further reinforce European dialogue on vital issues from the liberal perspective.



ELF Studio Europe

Supported by Haya van Someren Stichting / VVD Internationaal

ELF Studio Europe brought together young and up-and-coming professionals from all around Europe, who were engaged in education and training programmes while focusing on finding answers to the challenges that liberalism faces in the 21st century.



Tell Me Your Story

Supported by Haya van Someren Stichting / VVD Internationaal Tell Me Your Story built on a series of advanced workshops for communication officers from all over Europe on storytelling and use of emotions in messaging. This year, a publication entitled "Scary Stories" looked into the discourse of fear used in countries such as Poland and Hungary both by populist leaders and by opposition groups, along with the impact this had on the rationalisation and justification of political positions.

Digital Czech Republic 2020

Supported by Institute for Politics and Society (IPPS)

The conference Digital Czech Republic 2020 was the fifth edition of this high-level conference attracting tech companies, start-ups, government officials, politicians, and think tankers. Taking the example of the Czech Republic, the conference explores how Europe can open up to technology whilst taking in its stride the new challenges presented in the field.



Liberal Leadership Academy 2020

Supported by Haya van Someren Stichting / VVD Internationaal

This Liberal Leadership Academy consisted of multiple workshops where a selected group of participants was trained on different personal and professional skills necessary for being active citizens in the public arena.






Multiple Challenges for Transatlantic Partnerships

Supported by Institute for Politics and Society (IPPS)

This conference was the fifth instalment of the Multiple Challenges series. The project focused on how the relationship between the U.S. and the EU – two key global partners – has developed during a complicated period. Touching on the economic, political, and defence fields, the status quo of the relationship was analysed by top experts from both sides of the Atlantic.





Human Rights in the 21st Century

Supported by NOVUM – Institute for strategic and applicable research

In 2018 the world celebrated the anniversaries of the UDHR and ECHR. Both documents are being challenged by the rise of illiberal political systems and complex issues, including rights to privacy and freedom of expression, AI, and the threat climate change poses to life, food, and water. The project aimed to discuss the opportunities and challenges for Human Rights in the 21st century.



European Trainers Academy

Supported by International Educational Centre, Haya van Someren Stichting / VVD Internationaal, Stichting IDI/ D66 International


This project aimed at establishing an ELF framework for the training of trainers to further promote capacity building and improve the quality of training across the liberal network.



Regional Policy Network

Supported by International Educational Centre, Haya van Someren Stichting / VVD Internationaal, Stichting IDI / D66 International

Regional Policy Network represented a comprehensive capacity-building programme that trained and empowered policy advisors and experts in Central and Southeast Europe, focusing on how to better understand, communicate, and shape policy.



EU Accession and Economic Freedom

Supported by Centre for Liberal Studies – Markos Dragoumis (KEFiM)

Previous studies have failed to demonstrate a strong correlation between EU membership and increases in economic freedom. This project devised a methodology for which to test this and went on to explore the correlation between the EU accession period and Economic Freedom, finding that some of the core elements were trade, protection of property rights, quality of regulation, and moderation of currency.

EU Enlargement in the next 5 years. Moving the Western Balkans Forward

Supported by Liberal Integration Foundation

Gathering top politicians from the Western Balkans and from the EU, including Commissioner Varhelyi, this hybrid conference addressed the question of EU enlargement in the next 5 years. Hoping to serve as a plea for moving the Western Balkans forward in the EU agenda, this conference also discussed the main stumbling blocks and challenges to the region's EU integration and how to address them.

ELF Executive Class

Supported by Centre for Liberal Studies – Markos Dragoumis (KEFiM)

In accordance with ELF's mandate to strengthen the liberal and democrat movement in Europe, the creation of this training programme aimed to improve the capacity and effectiveness of ELF MOs by providing a state-of-the-art course on think tank capacity. This course has been tailormade for think tank leaders from the ELF network of 46 MOs who are interested in learning from industry experts and sharing knowledge with their peers.





Liberal Europe Podcast and Videocast

Supported by Movimento Liberal Social

Following on from two successful seasons, the Liberal European Podcast continued for a third year, welcoming top guests from around the continent to discuss issues of European interest with host Ricardo Silvestre. Additionally, this year's podcast has been supplemented by a videocast, bringing in video content, like short documentaries and explanatory videos, proven to be a good way to convey liberal values or policies.





Basic Social Security in the 21st Century

Supported by NEOS Lab

What does social security in the 21st century mean, and how can it be designed? In an era of new forms of mobility, a revolution of the working environment, and a fast-changing demographic, social security systems need to adapt. This project aimed to develop a common European understanding, discussing basic income theories and experiments, as well as innovative ways to reform social security systems from a liberal perspective.



It's the Environment, Stupid! Liberal Climate Change Solutions

Supported by NEOS Lab

How we manage the transition to an ecologically sustainable economic and industrial system is a key question for the 21st century, which is often answered with illiberal solutions like bans and regulations. Through a study and workshop, the project aimed to create a liberal vision for climate change policies and showcase successful existing best-practice solutions.



Hate Speech at the Service of Politics

Supported by Projekt: Polska

This project explored how hate speech has been instrumentalised for political gains. It culminated in a comparative study on hate speech as a prevalent component of the identity of the populist movement in all 27 EU member states, bringing examples from each country, and the relevant responses (or lack thereof) from public bodies, political parties, and civil society.

Internal Migration in the European Union: Liberal Answers

Supported by Republikon Foundation for Science, Education and Research (Republikon Foundation)

This project aimed to assess and discuss the consequences of internal migration in the EU. The project pointed out that the free movement of the workforce should promote a European single market, global competitiveness, and stability, not social and political disturbance. It also looked into the impact of Brexit with regards to internal migration, and the closing of borders during the COVID-19 pandemic.

The Future of the Liberal Visegrad Project

Supported by Republikon Foundation for Science, Education and Research (Republikon Foundation)

This project assessed the political relevance of the Visegrad cooperation. Despite getting a lot of bad press when it comes to liberal standards, there is potential for the Visegrad group to draw on its historical roots and pursue a course of liberal politics. The publication analysed the liberal roots of the cooperation, the role of the V4 in the EU, the neighbourhood policies of the group, the illiberal tendencies, and the future of liberal democracy in the Visegrad countries.







COVID-19 & Human Rights

Supported by Republikon Foundation for Science, Education and Research (Republikon Foundation)

This project assessed the illiberal tendencies, freedom restrictions related to emergency measures, and centralisation during the COVID-19 pandemic and the subjective perception of such tendencies in the Czech Republic, Hungary, Poland, and Slovenia. Furthermore, the project analysed whether the emergency situations and special measures undertaken by central governments could have an irreversible effect on human rights and individual freedom. Thus, it focused on citizens' reactions and attitudes.





Hacking Europe's Future

Hacking Europe's Future was a one-day conference and two-day brainstorming event, which focused on rebranding and reimagining Europe. The project aimed to build on reform ideas for Europe, elaborated in an ELF white paper, to redefine the interaction between leaders and citizens regarding the EU, and promote citizens' demands for greater vision and substance.



EU Mentorship 2020: WB and EaP Integration to the EU

The project provided political mentorship to liberal political activists in non-EU Western Balkan countries and Eastern Partnership member states. It aimed to prepare them for EU accession processes, as well as push the topic of future EU enlargement beyond the simple 'pro et contra' arguments onto more solution-oriented discussions.



Mission: New Engagement

Mission: New Engagement focused on modern membership and innovative forms of civic engagement. Through interactive workshops, it looked for new ways of activating people in political organisations and fresh ideas for using social activism in politics. Building on the 2019 edition, the topic for 2020 was "Is Online Better Than Offline?".

My Academy | E-Learning Platform

If 2020 had a profile online, it would have the worst reviews ever. It was a year full of uncertainty, restrictions, and cancelled plans. A lonely year. A year that forced everyone out of their comfort zones. But it was also a year that called for resilience, a strong resolve to overcome these difficulties and continue pursuing our goals.

"Some see 2020 as the end of an era; for us in the Policy and Research Unit it was — quite literally — a new beginning." The Policy and Research Unit was created amidst a pandemic with the mission to monitor, analyse, and contribute to the debates on European public policy, support member organisations, and promote ELF's purpose and objectives.

Despite everything, we managed to adapt to the new working conditions and lay the foundations for an exciting future ahead of us.

With the publication of our first Discussion Papers, we initiated a new series of research formats that will become a launching pad for evidence-based policy proposals and the liberal ideas of our network. With the launch of our first blogpost series – London Calling and Spotlight European Integration – we established our intention to stir discussion on the pressing issues of European policy, adapt to a fast-paced news cycle, and use flexible publication formats to get our message across.

In 2020 we also launched our internal newsletter. Every two weeks, the Liberal Wire keeps you up to date with latest developments in Brussels and the EU institutions, but also features events, publications, calls, and other activities that take place within our network. We plan to keep this momentum: in supporting our member organisations and leveraging the power of our network; in strengthening our partnership with the ALDE Party and the Renew Europe Group in the European Parliament; and in conducting timely, evidence-based research that matters to those who set policies.






The Voice of Youth

To capture the immediate economic and social effects of the Covid-19 crisis, ELF and the University of Ljubljana launched a large-scale on-line survey across the world between 5 May and 15 June 2020.
