21 Research Center (Hungary):

The Hungarian 21 Research Center is an established research partner of ELF's IBM (Inditsuk Be Magyarorszagot), the political foundation of their local liberal party, Momentum Movement. Focusing primarily on data collection and data analysis, 21 Research Center wants to leverage the research expertise it has developed over the years and apply it in an international context.



Venstres Studieforbund (Norway):

Venstres Studieforbund (VS), a study association linked to the Norwegian Venstre Party, joined ELF as an affiliate member in 2021 as the first and only Norwegian member to this date. Norway's EU membership has become more important since the full-scale Russian invasion of Ukraine. Being an independent civil society organisation, the Europe-Georgia Institute focuses its campaigning on issues such as human rights, peacebuilding, the promotion of good governance, democratic resilience, the fight against propaganda and disinformation and supports the involvement of youth in democratic process.

The Institute for Freedom and Democracy (ILD) is an independent liberal think-thank that has been established in 2019 aiming to promote and preserve the values of freedom and democracy in Romania. The Foundation for Liberal Public Policy, (FLPP) (Foundacija za liberalnu prakticnu politiku) was founded in 2021 with the aim of promoting liberal values and policies in Serbia, and the region. The main activity of the Foundation includes the creation of public policy proposals in key areas of social functioning, based on the analysis of existing problems, previous knowledge in the given area, and the selection of optimal solutions grounded in research, statistical indicators, and good practices.



Liberal Action (Moldova):

Liberal Action (Acţiunea Liberală) is a newly emerging think-tank from Moldova. Liberal Action represent a committed group of pro-EU activists in Moldova who aim to support democratic changes and prosperity, sharing the benefits of the free market and European model of governance. Based in a candidate country to the European Union, Liberal Action will serve as a policy hub between ELF and other organisations that play their role in creating internal consensus over the policies, bringing Moldova closer to the EU.

Liberal Democracy Institute (Lithuania):



Liberal Democracy Institute is an analytical centre (think tank) of the Laisvės partija (Freedom Party) that carries out analytical work, research and educational activities. In its activities, the institute spreads liberal ideas; promotes respect for personal freedom, democracy, equality, the rule of law, and human rights. Operating principles of the Institute of Liberal Democracy include rule of law and separation of powers, respect for private property and economic initiative, fostering respect for diversity and an open society, personal responsibility, transparency and citizenship and more.

The Reforms and Research Group (Georgia):



The Reforms and Research Group is a civil society organization founded in Georgia dedicated to promoting the development of liberal values and democratic institutions as well as civil society. The main value of the organization is the person, and we strive to promote the formation of a society based on values. The Reforms and Research Group unites modern thinkers, researchers, scientists, and active members of civil society with common interests to actively focus on issues such as (but not only on) human rights, transparent and fair elections, euro integration, and education. Our organization actively works on policy issues and creates reform packages that aid the ruling government in enacting effective policy

O Tara ca Afara (Romania):



O Tara ca Afara was established in 2021 with the main goal to monitor the implementation of Romania's Recovery and Resilience plan, focusing particularly on the specific reforms that are key to the country's liberal transition, as well as more in general, to its modernization through an impactful absorption of all EU funds. Moving forward, it continued to develop, expanding its area of activity towards becoming a strong liberal voice in the country and think tank arena. Being founded by Cristian Ghinea, former USR minister of Investments and European Projects and chief negotiator for Romania's Recovery and Resilience Plan, the organisation was able to capture the attention of a wide public following this specific topic and its exposure continues to grow. The main objective is to position the organisation as a strong liberal voice, something Romania truly needs to have in a moment of decreasing trust in the EU shared by the citizens.

ELF's impact in 2023

Policy and research with impact

Techno-Politics

The Techno-Politics Forum 2023 brought together industry leaders, politicians and academics to debate and share insights on some of the biggest issues facing Europe in the technological sphere. Techno-Politics Forum, which is more than an event, aims to build up a community which will turn the challenges into innovation and problems into solutions. This year's edition of the conference focused on three critical spheres – clean energy, connectivity and artificial intelligence.

ELF also hosted two stakeholder dialogues in 2023 at the European Parliament with around two dozen participants from the European institutions, associations, civil society and tech and telecom industries. The first one was hosted by MEPs Svenja Hahn and Sandro Gozi and focused on Digital Strategic Autonomy. The second event was hosted by MEP Alin Mituta and focused on the future of EU connectivity and the relevant legislation.

Security & Defence

In 2023, ELF has also done a significant work on the topics of security and defence. We started the year with the opening of the debate on the European Defence and Security Agenda during a working group at our General Assembly in Paris. Our study 'Towards a New European Security Architecture', alongside several policy papers on defence and security, provided a comprehensive and policy-oriented proposal to tackle the everpresent threats to European security and democracies.

In order to take the discussion a step further, we have also dedicated the third edition of our Future Europe Journal to exploring how Europe has been transitioning to new modes of functioning due to its multi-faceted crisis management..

Staged integration to complete the EU project

In the ambitious pursuit of reshaping the European Union's enlargement policy, we proudly launched the Staged Integration roadshow, a strategic initiative conceptualized in collaboration with eminent think-tanks and other valuable partners. The concept of 'Staged Integration' represents a pioneering approach to EU enlargement, designed to

offer a dynamic, phased process of integration that aligns with the evolving capacities and aspirations of candidate countries. Our efforts culminated in a series of presentations to the Renew Europe Group, bolstered by robust research and compelling advocacy, to underscore the viability and necessity of our approach. The concept gained substantial traction, earning the endorsement of key policymakers and stakeholders within the EU framework

We extended our outreach beyond the EU, engaging directly with the Ambassadors of the Western Balkans, before taking the concept to the heart of the matter: our Staged Integration Roadshow last year included stops in North Macedonia, Bosnia, and Serbia. In these countries, our advocacy not only resonated with local partners but also captured the attention of the media and became part of the domestic political discourse, marking a significant milestone in our campaign. Our efforts have not only contributed to the reinvigoration of the EU enlargement dialogue but have also positioned Staged Integration as the leading narrative for the future of Europe's expansion.

Human rights & democracy

In 2023, we continued to expand our impact on divesity and inclusion across Europe thanks to our Academy projects – Rainbow Platform and Alliance of Her.

The Rainbow Platform initiative elevated LGBTQI+ voices by creating role models who can inspire political engagement and change, redefining how we approach diversity in politics and within our organisations. In 2023, the Academy took part in three Circles of Diversity sessions, empowering the participants to succeed in leadership roles.

The Alliance of Her (AOH) project created an important space to empower women in Europe to lead, in pursuit of a more diverse and inclusive future for all. In 2023, the AOH prepared a new class of passionate voices for leadership through the Academy and expanded the Allies and Alumnae Network, creating a powerful network sharing knowledge, experience and inspiration.

ELF's 15th anniversary and Liberal Awards

2023 marked a very important year in the European Liberal Forum's history: the organisation celebrated its 15th anniversary with its liberal family in Brussels. It was a great opportunity to reflect on our goals for a liberal future, with high-level guests. During the celebration, ELF presented the winners of the third edition of the Liberal Awards. ELF's annual Liberal Awards celebrates the champions of liberal values and ideas and ensures their recognition and impact on the European level. The 2023 ceremony took place at the House of the Capital Region in Brussels on 27 September, in the presence of the liberal political family, ELF member organisations, partners and the press.

Estonian Prime Minister Kaja Kallas was presented with the Liberal of the Year award by Belgian Prime Minister Alexander De Croo. MEP Guy Verhofstadt, former prime minister of Belgium and former leader of the ALDE Group in the European Parliament, was presented the award for Lifetime Achievement by ALDE Party Co-President MEP Ilhan Kyuchyuk, Timmy Dooley and Renew Europe Group VP MEP Katalin Cseh. Political campaigner and founder of the Rainbow Platform, Luis Cano was presented the award for Rising Star by ELF Vice President, MEP Jan-Christoph Oetjen and Board Member Antoaneta Asenova-Bihlmayer.

Participation in ALDE Manifesto process

Throughout 2023, our active engagement in the ALDE Manifesto process has yielded significant outcomes that have both fortified our policy positions and amplified our impact on the European political landscape. Our participation was strategic and focused, evidenced by our presence on the manifesto drafting committee and the meaningful proposals we submitted. Notably, three of our amendments pertaining to media freedom, civil society support, and the EU's strategic autonomy and defence capabilities were partially incorporated. These topics are crucial for the functioning of the EU's democratic and security structures, and our influence in these areas reflects our commitment to having a lasting impact on core positions of our political family.

The most remarkable success, however, was the full adoption of our amendments on staged integration and EU treaty reform. Our advocacy for staged integration was not only acknowledged but also embraced by the party, leading to a paradigm shift in policy approach. The concept's adoption signifies a transformative step towards a more cohesive and effective integration process within the EU. Similarly, the amendment on EU treaty reform broke new ground by piercing the long-standing taboo against EU treaty change. Our efforts paved the way for an overdue recognition of the necessity for institutional reforms within the EU, demonstrating our capacity to drive substantial policy evolution. These achievements underscore the tangible impact of ELF's policy work, further strengthening our position as an influential voice within the ALDE party and the broader EU policymaking debates.
